Council member Milleson seconded the motion and it passed all ayes.

The Council received a report from the Story County Sheriff's Department.

Joe Robertson from the Solid Waste Management Commission of Marshall County answered questions from the Council regarding the Marshall County Landfill.

Council member Norgart arrived at 7:15 p.m.

The Council received a funding request from Community and Family Resources for fiscal year 2015.

Mayor Wilson made the following council committee appointments: Mayor Pro tem: Otto. Finance: Norgart, Conrad. Utilities: Conrad. Streets: Nichols, Otto. Recreation: Norgart. Solid Waste: Milleson, Conrad. Cemetery: Norgart. Crossroads Festival: Otto, Nichols. Fire Board: Milleson.

Council member Conrad introduced AN ORDINANCE AMENDING THE CITY CODE OF THE CITY OF COLO, IOWA, BY DELETING SECTION 5-1.08 AND ADDING A NEW SECTION 5-1.08 PROVIDING FOR APPOINTMENT OF ALL MEMBERS OF THE RECREATION BOARD BY THE COUNCI and moved its approval on first reading. Council member Norgart seconded the motion. After discussion, Council member Conrad withdrew the motion. No action taken.

Council member Conrad introduced and moved the approval of a RESOLUTION MAKING APPOINTMENT OF REPRESENTATIVE AND ALTERNATE REPRESENTATIVE TO THE CENTRAL IOWA REGIONAL HOUSING AUTHORITY. Council member Norgart seconded the motion and it passed with record vote as follows: Ayes: Milleson, Nichols, Conrad, Otto, Norgart. Nays: None. Whereupon the Mayor declared the motion carried and the resolution adopted and he gave it No. 14-2-1 for the record.

Council member Otto moved to approve the 6 year Capital Improvements Program as submitted by the Colo Planning & Zoning Commission for the period 7-1-14 thru 6-30-20. Council member Nichols seconded the motion and it passed all ayes

The Council received a report from Drew Kamp, Story County Community Outreach Director.

Tony Bellizzi of Veenstra and Kimm Engineering gave an update on street improvement plans for Second Street from Main to Bailey, Bailey Street from Second Street to US Hwy. 65 and South Street from US 65 to Fourth Street.

The Council reviewed the proposed 2014-15 city budget. Council member Norgart moved to set the date of March 3, 2014, at 7:15 p.m. for a public hearing on the FYE 6-30-15 budget. Council member Conrad seconded the motion and it passed all ayes.

Council member Milleson moved to direct the city clerk to correspond with the Solid Waste Management Commission of Marshall County regarding the possibility of the City of Colo joining the Commission. Council member Conrad seconded the motion and it passed all ayes.

The Council reviewed the job description for the City Clerk/Maintenance Superintendent position. Council members Nichols and Milleson will serve as a committee to establish a pay scale and benefits schedule for the position.

There being no further business to come before the meeting Council member Milleson moved to adjourn. Council member Conrad seconded the motion. The motion carried and the meeting adjourned.
