February 4, 2019

The Colo City Council met in regular session on Monday, February 4, 2019 at City Hall. The meeting was called to order at 7:00 p.m. by Mayor John Wilson. The roll was called showing members present and absent as follows: Present: Stoeffler, Spalding, Geisinger, Otto and Handsaker. Absent: None.

Council member Geisinger moved to approve the minutes of the January 7, 2019 regular meeting as presented. Council member Handsaker seconded the motion and it passed all ayes.

Council member Spalding seconded the motion and it passed all ayes.

Story County Sheriff, Jordan Lenz informed the council to keep cars locked when parked. A vehicle was stolen from the school.

Fire Chief, Dennis Clatt told the council medical calls increasing. Clatt is still gathering information on the parking lot.

Librarian, Joanie Jamison discussed with the council all the activities coming up at the Library. March "Coffee and Conversations" will feature the new managers of Niland's Café. Security camera discussions were made. More information is being gathered on the cameras. Discussions on having at least two employees working in the library at the same time.

Council member Geisinger moved to approve the 2020 Law Enforcement Contract with Story County. Council member Spalding seconded the motion and it passed all ayes.

The council discussed the upcoming budget. A budget workshop is planned for Monday, February 11th at 6:00 p.m.

Council member Handsaker moved to approve the FYE 6-30-20 budget public hearing will be March 4th at 7:15 p.m. Council member Spalding seconded the motion and it passed all ayes.

Council member Otto moved to approve the agreement with the Iowa Department of Transportation on ramp resurfacing. Council member Geisinger seconded the motion and it passed all ayes.

The council discussed weight limitations for the Heartland Co-op. Council member Spalding moved to approve the increase in weight limits from February 1, 2019 to March 1, 2019. The council will revisit yearly. Council member Handsaker seconded the motion and it passed all ayes.

Council member Spalding moved to approve the purchase of a Kubota UTV, v-plow, and broom. Council member Stoeffler seconded the motion and it passed all ayes.

The housing development was discussed.

In other business Austin Fortch was concerned about the city snow removal. The council said the crowned city streets are the problem.

There being no further business to come before the meeting, Council member Handsaker moved to adjourn. Council member Spalding seconded the motion. The motion carried and the meeting adjourned.
