

Proceedings of the Colo City Council
March 2, 2015

The Colo City Council met in regular session on Monday, March 2, 2015, at City Hall. The meeting was called to order at 7:00 p.m. by Mayor John Wilson. The roll was called showing members present and absent as follows: Present: Otto, Geisinger, Nichols, Conrad. Absent: Milleson.

Council member Conrad moved to approve the minutes of the February 2, 2015, meeting as presented. Council member Geisinger seconded the motion and it passed all ayes.

Council member Nichols seconded the motion and it passed all ayes.

The Council received reports from the Story County Sheriff's Office. The officer stated the city had one reported burglary. Otherwise the city has been quiet. Council member Nichols gave an update on the Colo Crossroads Festival celebration. Events are starting to come together and volunteers are still needed. Council member Geisinger gave a report from the Cemetery Board. Restorations are going to be made on some of the older tombstones.

Council member Conrad moved to approve the tax abatement for an addition at 302 Second St. Council member Nichols seconded the motion and it passed all ayes.

Council member Geisinger introduced a RESOLUTION ESTABLISHING AND REGULATING RATES TO BE CHARGED FOR THE DISCONNECTION OF WATER FOR DELINQUENCY IN THE CITY OF COLO, IOWA. Council member Milleson seconded the motion and it passed with record vote as follows: Ayes: Conrad, Nichols, Geisinger, Otto, Milleson. Nays: None. Whereupon the Mayor declared the motion carried and the resolution adopted and he gave it No. 15-3-2 for the record.

Council member Milleson introduced a RESOLUTION PROHIBITING PARKING ON THE SOUTH SIDE OF SOUTH STREET FROM U.S. HIGHWAY 65 TO SECOND STREET IN THE CITY OF COLO, IOWA. Council member Otto seconded the motion and it passed with record vote as follows: Ayes: Conrad, Nichols, Geisinger, Otto, Milleson. Nays: None. Whereupon the Mayor declared the motion carried and the resolution adopted and he gave it No. 15-3-3 for the record.

At 7:15 p.m. the Mayor declared it was the time and the place for the public hearing on the city budget for the fiscal year ending 6-30-16. There were no comments received and the hearing was closed. Council member Nichols introduced and moved the approval of a RESOLUTION ADOPTING BUDGET AND CERTIFICATION OF CITY TAXES FOR THE FISCAL YEAR BEGINNING JULY 1, 2015. Council member Geisinger seconded the motion and it passed with record vote as follows: Ayes: Conrad, Nichols, Geisinger, Otto, Milleson. Nays: None. Whereupon the Mayor declared the motion carried and the resolution adopted and he gave it No. 15-3-1 for the record.

Other items discussed included enforcing all properties having visible house numbers posted on their homes to help emergency crews find locations. The clerk is beginning to collect information for all vehicles without current license plate tags. She will be citing those not in compliance. Discussions were also made on posting city ordinances on the city website. The clerk is looking into the appropriate actions.

There being no further business to come before the meeting, Council member Milleson moved to adjourn. Council member Conrad seconded the motion. The motion carried and the meeting adjourned.
