

Proceedings of the Colo City Council
March 6, 2017

The Colo City Council met in regular session on Monday, March 6, 2017, at City Hall. The meeting was called to order at 7:00 p.m. by Mayor John Wilson. The roll was called showing members present and absent as follows: Present: Conrad, Otto, Geisinger, Nichols, and Spalding. Absent: none.

Council member Otto moved to approve the minutes of the February 6, 2017 regular meeting as presented. Council member Geisinger seconded the motion and it passed all ayes.

Council member Geisinger seconded the motion and it passed all ayes.

Officer Sink gave a report from the Story County Sheriff's Office. Not many problems the past month.

Fire Chief, Dennis Clatt gave a report on the Colo Fire Department. There were 20 less calls last year compared to the previous. A mild winter may have to do with that. Discussions were made on updating gear and other equipment. Attack truck is being painted and almost ready to go.

Joanie Jamison from the Colo Public Library gave a report. On May 4, 2017, Iowa's Hidden Treasures is coming in to talk about restaurants and other venues in Iowa.

At 7:15 p.m. the Mayor declared that this was the time and the place for a public hearing on the city budget for fiscal year ending 6-30-18. There were no comments received and the hearing was closed. Council member Conrad introduced and moved the approval of a RESOLUTION ADOPTING BUDGET AND CERTIFICATION OF CITY TAXES FOR FISCAL YEAR BEGINNING JULY 1, 2017 AND ENDING JUNE 30, 2018. Council member Nichols seconded the motion and it passed with record vote as follows: Ayes, Nichols, Otto, Geisinger, Conrad. Nays: None. Whereupon the Mayor declared the motion carried and the resolution was adopted and he gave it 17-3-1 for the record.

At 7:20 the Mayor declared that this was the time and the place for a public hearing on the city budget amendment for fiscal year ending 6-30-17. Council member Spalding introduced and moved the approval of a RESOLUTION ADOPTING BUDGET AMENDMENT AND CERTIFICATION OF CITY TAXES FOR FISCAL YEAR BEGINNING JULY 1, 2016 AND ENDING JUNE 30, 2017. Council member Nichols seconded the motion and it passed with record vote as follows: Ayes, Nichols, Otto, Geisinger, Conrad. Nays: None. Whereupon the Mayor declared the motion carried and the resolution was adopted and he gave it 17-3-2 for the record.

Council member Nichols moved to approve the sale of lot 8 at the Colo Business Park public hearing will be April 3, 2017 at 7:15 p.m. Council member Geisinger seconded the motion and it passed all ayes.

Discussions on amending the golf cart ordinance by adding UTV's and ATV's were had. All agreed on the proposed ordinance. All agreed proof of insurance and a \$30.00 yearly registration fee will be required. It will be approved at the April meeting.

Discussions on Hickory Grove Park hooking up to the Colo lagoon were made. More information is being gathered for the city engineer. Council would like engineer to speak at April's meeting on this issue.

The rough draft of the employee handbook was looked over. Changes are being made and more discussions will be made at April meeting.

Discussions on the housing development were made. More information is being gathered.

There being no further business to come before the meeting, Council member Conrad moved to adjourn. Council member Geisinger seconded the motion. The motion carried and the meeting adjourned.
