The Colo City Council met in regular session on Monday, July 3, 2017, at City Hall. The meeting was called to order at 7:00 p.m. by Mayor Pro-tem Earl Otto. The roll was called showing members present and absent as follows: Present: Geisinger, Nichols, and Spalding. Absent: Conrad, Wilson.

Council member Spalding seconded the motion and it passed all ayes.

Fire chief, Dennis Clatt, told the council what the department is doing for the Colo Crossroads Festival. They will be serving a pork dinner from 5 p.m. to 7 p.m. Friday night of the festival. Following the supper they will be doing the Mud Mania opstical course. The department received another Prairie Meadows grant to purchase a dryer for fire gear. They have applied for another grant to help purchase new call radios. Clatt also stated that emergency calls have been slow.

At 7:15 the Mayor Pro-tem declared that this was the time and the place for a public hearing on the sale of Lots 1, 2, and 3 at the Colo Business Park. There were no comments received and the public hearing was closed.

Council member Spalding introduced and moved the approval of a RESOLUTION CLOSING THE PUBLIC HEARING, APPROVING THE PROPOSED SALE OF CITY OWNED PROPERTY TO Voltmer Inc. Council member Spalding seconded the motion and it passed with record vote as follows: Ayes, Nichols, Spalding, Geisinger. Nays: None. Whereupon the Mayor declared the motion carried and the resolution was adopted and he gave it 17-7-1 for the record.

Council member Spalding introduced and moved the approval of a RESOLUTION APPROVING THE EXECUTED DEED FROM THE CITY OF COLO TO VOLTMER INC FOR PURCHASE OF LOTS 1, 2, 3 AT THE COLO BUSINESS PARK. Council member Nichols seconded the motion and it passed with record vote as follows: Ayes, Nichols, Spalding, Geisinger. Nays: None. Whereupon the Mayor declared the motion carried and the resolution was adopted and he gave it 17-7-2 for the record.

Council member Spalding moved to approve allowing the waiving the Colo Subdivision Ordinance and allow a single parcel to be created by survey of plat for the Norbert Kash Estate lot.

Council member Geisinger moved to approve the purchasing of new overhead doors on the public works building. Council member Spalding seconded the motion and it passed all ayes. Clerk Kohlwes is gathering more information on the different colors and choices of doors.

The council discussed deeding Michaels drive back to the new owner of the Ostrem addition. The council would like Mr. Gannon to tell them his plans at the next council meeting.

Discussions on the housing development were made. More information is being gathered.

Discussions on the state passing fireworks ordinance were made. The ordinance will be brought to the council for the August meeting.

There being no further business to come before the meeting, Council member Geisinger moved to adjourn. Council member Spalding seconded the motion. The motion carried and the meeting adjourned.
