August 3, 2020

The Colo City Council met in regular session on Monday, August 3, 2020 at the Colo Fire Department. The meeting was called to order at 7:00 p.m. by Mayor Arlo Starbuck. The roll was called showing members present and absent as follows: Present: Adams, Stoeffler, and Geisinger. Absent: Spalding and Handsaker.

Council member Adams moved to approve the minutes of the July 6, 2020 regular meeting as presented. Council member Geisinger seconded the motion and it passed all ayes.

Council member Adams seconded the motion and it passed all ayes.

Colo Public Librarian, Joanie Jamison reported the library is still on Covid hours. Discussions on renovations were had.

Fire Chief, Dennis Clatt stated calls are up with nothing COVID related. The department looked at demo pumper truck.

Council member Geisinger moved to approve RESOLUTION INCREASING COMMERCIAL GARBAGE RATES. Council member Adams seconded the motion and it passed with record vote as follows: Geisinger, Adams, and Stoeffler. Nays: none.

Whereupon the Mayor declared the motion carried and the resolution was adopted and he gave it 20-8-1 for the record.

Council member Geisinger moved to approve sewer line work with Central Iowa Televising up to \$20,000. Council member Stoeffler seconded the motion and it passed all ayes.

Mike Cox of Story County Conservation discussed with the council the Hickory Grove sewer line. The City engineer will have more information at the September council meeting.

Council member Stoeffler moved to approve extra paving at the Niland ramp. Council member Adams seconded the motion and it passed all ayes.

Mike Gaedke asked the council to forgive sewer rates for watering his sod. Lack of motion from the council.

In other business Council member Adams wants to cleanup sidewalk weeds on South Street. Nancy Henry wanted to know if we could send nuisances out for poor sidewalks. These issues are being looked into. Jan Gammon of the Lincoln Highway Association was concerned with the Niland's Café closing. The City doesn't have anything to do with the Reed/Niland corner but Colo Development Group President, Joanie Jamison told the council there are several prospects of taking it over after the recent closure.

There being no further business to come before the meeting, Council member Adams moved to adjourn. Council member Geisinger seconded the motion. The motion carried and the meeting adjourned.
