Council member Nichols seconded the motion and it passed all ayes.

The Council received reports from the Story County Sheriff's Department and the Colo Public Library.

Council member Conrad moved to approve the appointment of Kelley Seyller to the Colo Library Board. Council member Peakin seconded the motion and it passed all ayes.

Blaine Tibben of Alliant Energy reviewed plans for upgrading Alliant's electrical facilities in Colo. The project will start this fall.

Drew Kamp of the Ames Chamber of Commerce & Economic Development informed the Council regarding his duties as director of community outreach for communities in Story County.

The Council received a report on the progress of the Standby Generator Project, Street Improvement Project, Sanitary Sewer Inflow and Infiltration Project, and the application for funding through the Story County Urban Renewal Program.

Council member Norgart moved to approve a class LE liquor license for Casey's General Store. Council member Nichols seconded the motion and it passed all ayes.

The clerk reviewed the upcoming city election timetable. The city election will be held on Tuesday, November 5. Voting will be at the Colo Community Center starting at 12:00 noon. Three City Council member seats will be up for election with the first day to file nomination papers August 26th and the last day to file will be September 19, 2013, at 5:00 p.m.

The Council received an update on the Community Visioning Program. The visioning steering committee will be planting at the pocket park and slab projects on Saturday, August 24, 2013. Volunteers are needed to help plant the flowers and shrubs.

The Council reviewed a request from Alliant Energy to remove 7 trees from city right-ofway. The Council agreed to allow Alliant to remove the trees subject to Alliant paying all costs associated with the removal.

There being no further business to come before the meeting Council member Norgart moved to adjourn. Council member Nichols seconded the motion. The motion carried and the meeting adjourned.
