August 6, 2018

Officer Jordan Lentz from the Story County Sheriff's Office stated all officers now have an electronic copy of the City's Ordinances. Joanie Jamison asked if the Sheriff's Office could help with a Stanger Danger type class with all the problems that have been happening around the state. Lentz is checking into it.

Fire Chief, Dennis Clatt stated medical calls are up. The city burn pile mysteriously keeps catching fire.

Colo Librarian, Joanie Jamison presented state statistics on similar sized libraries in Iowa. Colo ranks well among them. Clerk Kohlwes stated the air conditioning unit is not working well and is probably in need of replacement. Estimates are being gathered.

The new sump pump ordinance was discussed. The city appointed plumbers will start inspections soon.

The housing development was discussed. More information is being gathered.

The Council discussed the Wilson Auction building. The Council is meeting with Bob Wilson on August 20<sup>th</sup>.

In other business, Scott Starling asked the council if there was any interest on selling a lot beside their property. More information is being gathered.

There being no further business to come before the meeting, Council member Stoeffler moved to adjourn. Council member Handsaker seconded the motion. The motion carried and the meeting adjourned.
