Council member Stoeffler seconded the motion and it passed all ayes.

Story County Sheriff, Officer Lentz stated the town has been quiet.

Fire Chief, Dennis Clatt asked the council if they would be okay with the department purchasing permanent Christmas lights. They will be LED under the soffit and controlled by the chief's phone. All agreed it would be fine.

Colo Librarian, Joanie Jamison told the council about the play practice going on for the Charlie Brown Christmas play. The library board has adopted some of the city's policies for paid holidays.

Council member Stoeffler moved to approve the Dog House liquor license. Council member Geisinger seconded the motion and it passed all ayes.

Council member Geisinger moved to approve the bid from Central Iowa Televising on fixing an infiltration problem located on Main Street. Council member Handsaker seconded the motion and it passed all ayes.

The tractor or ranger was tabled to the next meeting.

Colo Historical Association presented a packet to the council. They are in need of a home and would prefer it be on Main Street. The Council suggested they take over the historic Niland's Café that is coming open for new management. The Association would prefer not to have that building. More information is being gathered.

The housing development was discussed. The City Engineer drew up a rough draft of a plat. The information has been passed along to the landowner and the council is awaiting a response.

Story County Board of Supervisors, Marty Chitty encouraged everyone to get out and vote. He agrees the council needs to support the Historical Association. He was happy to hear we are working on our I & I issue.

There being no further business to come before the meeting, Council member Stoeffler moved to adjourn. Council member Handsaker seconded the motion. The motion carried and the meeting adjourned.
