December 3, 2007

The Colo City Council met in regular session on Monday, December 3, 2007, at City Hall. Mayor John Foley called the meeting to order at 7:00 p.m. The roll was called showing members present and absent as follows: Present: Otto, Woods, Wilson, Snodgrass, Stoeffler. Absent: None.

The Council received reports from the Story County Sheriff, the Colo Recreation Board and the Colo Public Library.

The Council reviewed a recommendation from the Colo Planning And Zoning Commission regarding a request from Heartland Coop to rezone property in Block 13, Blair's Addition. Council member Woods moved to hold a public hearing on January 7, 2008, at 7:30 p.m. on the rezoning request by Heartland Coop. Council member Otto seconded the motion and it passed all ayes.

Council member Wilson moved to approve a Designated Physician Policy Statement. Council member Stoeffler seconded the motion and it passed all ayes.

The Council discussed the 2008-09 budget. Funding requests will be received at the January regular meeting.

The Council reviewed the status of nuisance abatement actions. The ordinance regulating junkyards was reviewed.

Mayor Foley administered the oath of office for Mayor to Larry E. Milleson and for Council member to Jason Dodd and Andrew Short for terms beginning January 1, 2008.

There being no further business to come before the meeting Council member Snodgrass moved to adjourn. Council member Otto seconded the motion. The motion carried and the meeting adjourned.
