Keosauqua, Iowa October 14-15, 2006

This application is for the indoor craft show (homemade crafts only, displayed by the crafter) at the Roberts Memorial Center, outdoor craft exhibits in the Keosauqua City Park, and the outdoor Flea Market along the river bank & city streets of downtown Keosauqua. All applications must be received in Keosauqua no later than Sept. 15th if you want to reserve a spot. If this is your 1st time as a vendor make sure you describe items to be sold.

As usual, no one is allowed to arrive before 8AM Thursday, Oct. 12th, You must check in with Jay Goldstein at the city park by the Hotel Manning to be shown to your spot. All spots are assigned. **(All Roberts Building Exhibitors must set-up no later than Friday night. The center will be locked until 8 AM Saturday, close @ 5 PM, then reopen @ 9 AM Sunday.)**

We do not send out confirmations, however we will notify you by Sept. 20th if we can't get you in for some reason.
